The scheme authorizes the State Legal Services Authority to grant permissions for establishing the Legal Aid Clinics in their respective State. 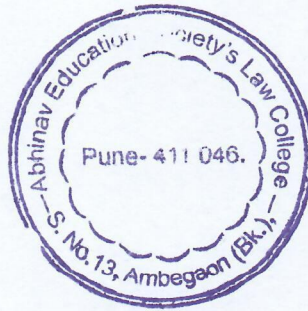
